Overview

Assembly Bill No. 1204 requires the Department of Health Care Access and Information (HCAI) to develop and administer a Hospital Equity Measures Reporting Program to collect and post summaries of key hospital performance and patient outcome data regarding sociodemographic information, including but not limited to age, sex, race/ethnicity, payor type, language, disability status, and sexual orientation and gender identity.

Hospitals (general acute, children's, and acute psychiatric) and hospital systems are required to annually submit their reports to HCAI. These reports contain summaries of each measure, the top 10 disparities, and the equity plans to address the identified disparities. HCAI is required to maintain a link on the HCAI website that provides access to the content of hospital equity measures reports and equity plans to the public. All submitted hospitals are required to post their reports on their websites, as well.

These rates are first stratified based on any eligible condition, mental health disorders, substance use disorders, co-occurring disorders, and no behavioral health diagnosis. Then, each condition-stratified hospital readmission rate is further stratified by race and/or ethnicity, non-maternal age categories, sex, payer type, preferred language, disability status, sexual orientation, and gender identity. Plan to address disparities identified in the data

To address disparities in all-cause readmissions and exclusive breast milk feeding, Adventist Health Ukiah Valley focuses on strengthening care transitions, improving access to follow-up care, offering culturally responsive education, and tracking readmission and breastfeeding metrics. Priority populations include ages 50â??64, 65+, males, American Indian/Alaska Native, Hispanic/Latino, White, Medicare, private payors, and Medicaid-insured patients. Our goals are to reduce readmissions by 10% and improve exclusive breastfeeding rates among Hispanic/Latino and Medicaid-covered births by 10% within 12 months.Đ

Readmission Reduction StrategyĐ

We use the readmission risk score to identify moderate- and high-risk patients before discharge. These patients are scheduled for a follow-up appointment within 10 days, and when no Primary Care Provider (PCP) exists, a hospital follow-up is arranged to prevent care gaps. Enhanced Care Management (ECM) referrals are made based on payer eligibility, with warm handoffs to community care management teams. Palliative care consults are requested for patients with complex needs, advanced illness, or high risk of return.Đ

To improve access, Federally Qualified Health Clinic (FQHC) and Rural Health Clinic (RHC) partners hold dedicated discharge follow-up slots for high-risk patients and those with Social Drivers of Health (SDOH) concerns. Monthly readmission metrics are reviewed by a multidisciplinary committee, with stratification by age, race, sex, payer, and diagnosis to guide targeted interventions. Exclusive Breastfeeding Equity D

To reduce disparities among Hispanic/Latino and Medicaid patients, we have expanded culturally and linguistically responsive lactation support. Several nurses hold or are pursuing International Board Certified Lactation Consultant (IBCLC) certification, including Spanish-speaking staff trained to address cultural bias, breastfeeding barriers, and individualized support needs.Đ Interventions include bedside lactation support, postpartum follow-up calls within 72 hours, culturally appropriate education, Women Infant Children (WIC) referral, and access to peer counseling, virtual

consults, and outpatient support groups. Breastfeeding rates, stratified by race/ethnicity and payer, are reviewed monthly through the maternal-child multidisciplinary committee to monitor improvement and adjust strategies.

Performance in the priority area

General acute care hospitals are required to provide hospital equity plans that address the top 10 disparities by identifying population impact and providing measurable objectives and specific timeframes. For each disparity, hospital equity plans will address performance across priority areas: person-centered care, patient safety, addressing patient social drivers of health, effective treatment, care coordination, and access to care.

Person-centered care

Adventist Health Ukiah Valley (AHUV) remains committed to advancing person-centered care by ensuring that every patientâ??s needs, preferences, values, and circumstances are integral to planning, delivery, and coordination of care. Our approach emphasizes dignity, respect, shared decision-making, culturally responsive engagement, and empowerment.Đ

Discharge planning begins at admission. Every patient is screened for risks and barriers that may impact a safe and healthy discharge, including social determinants of health, health literacy, caregiver availability, transportation, housing stability, access to food, medication concerns, and psychosocial needs. These screenings guide our team to proactively identify needs and intervene early.Đ

Discharge planning is a collaborative process that actively includes the patient, family, or caregiver in conversations about goals, capabilities, and preferred settings for recovery. We consistently use open dialogue to honor patient preferences and personal goals, whether related to social support, aftercare services, or end-of-life priorities. Patients are provided clear, understandable information and are asked how they want to participate in their care decisions. Đ

Patients are presented with services and supports available within the community, and their choices drive aftercare and support referrals. This may include home health services, palliative care, Enhanced Care Mangement (ECM) referral, caregiver training, behavioral health, substance use services, transportation assistance, telehealth support, or community-based organizations. When patients express a preference for a particular provider, service model, or cultural approach, those options are explored and incorporated whenever possible.Đ

Our case managers, nurses, social workers, palliative care, and ECM teams collaborate to develop personalized transition plans that reflect the patientâ??s preferences, risk factors, and available supports. Interpreter services and bilingual staff support communication and cultural alignment.

Shared decision-making tools and plain-language materials are used to ensure understanding and support autonomy.Đ

Virtual care and phone outreach are used to support continuity and help patients ask questions and remain engaged post-discharge. For patients facing complex medical or social challenges, palliative care consults, chronic care management, or community health worker support are offered in alignment with patient values and goals.Đ

Patients are encouraged to articulate what matters most to them in their recoveryâ??not just medically, but socially, emotionally, and spiritually. This â??what matters to meâ?• approach helps foster partnership, trust, and alignment with personal values. Our teams reinforce that patients are not recipients of care but active participants in shaping it.Đ

Data on readmissions, referrals, patient experience, and SDOH needs are reviewed monthly to identify gaps and improve person-centered practices. Feedback from patient experience surveys, care transitions reviews, and multidisciplinary committees guide improvement efforts. As part of continuous learning, staff receive education in health equity, trauma-informed care, cultural humility, and motivational interviewing to better support truly person-centered care. Đ

Through these efforts, AHUV ensures that person-centered care is not a task but a philosophy that is deeply embedded into how care is planned, delivered, and experienced across all settings.

Patient safety

At Adventist Health Ukiah Valley (AHUV), patient safety extends beyond clinical care to include discharge readiness, behavioral health needs, and social risks that impact safe recovery. Every patient is screened for discharge safety, health literacy, and Social Drivers of Health (SDOH) concerns such as housing, food security, transportation, substance use, and access to follow-up care. These screenings guide referrals to case management, Enhanced Care Management (ECM), social work, addiction medicine, palliative care, home health, or community partners to ensure safe and supported transitions.

For patients identified with substance use disorders, we provide safe, respectful, and coordinated support through the Substance Use Navigator (SUN), addiction medicine consults, ECM referrals, behavioral health connections, and follow-up planning before discharge. When appropriate, harm reduction resources and naloxone education are provided to reduce risk post-discharge. Patients experiencing homelessness or housing instability are offered weather-appropriate clothing, a meal, and transportation to their preferred location or community resource. When available, we connect them with shelters, local agencies, and housing support programs. We believe safe discharge also means addressing dignity, warmth, nutrition, and access to basic resources. Discharge planning is collaborative, involving nurses, physicians, case managers, pharmacists, and social workers. Medications are reconciled for accuracy, affordability, and risks, and discharge instructions are provided in plain language and with interpreter support as needed. Teaching focuses on what matters most to the patient and helps ensure they understand symptoms that may require medical attention. D

Patient safety performance is monitored monthly through multidisciplinary reviews, focusing on readmissions, adverse events, substance use-related safety concerns, Emergency Department (ED) revisits, safe discharge outcomes, and referrals to ECM or community services. These meetings help identify trends and drive improvement.

By integrating clinical, behavioral, and social safety approaches, AHUV promotes safe, personcentered transitions and supports equity in patient outcomes.

Addressing patient social drivers of health

Adventist Health Ukiah Valley (AHUV) actively integrates social determinants of health (SDOH) into care planning to improve safe recovery, reduce readmissions, and support whole-person care. Social Drivers of Health (SDOH) are screened at every admission using a standardized assessment that identifies risks related to housing, food insecurity, transportation, behavioral health, medication

access, caregiver support, and financial or insurance barriers.Đ

All patients with positive screens receive a social work consult when possible, and Enhanced Care Mangment (ECM) is engaged for those who meet eligibility criteria. When ECM is activated, a warm handoff is facilitated between the inpatient team and outpatient care management to ensure continuity of care post-discharge. This includes support with appointment scheduling, addressing transportation barriers, connection to primary care, and linkages to community agencies, tribal health partners, Rural Health Clinics (RHCs), and Federally Qualified Health Clinics (FQHCs). Decare teams collaborate with community-based organizations to help patients access housing resources, addiction recovery programs, food support, transportation vouchers, caregiver services, WIC, and behavioral health care. SDOH needs are incorporated into discharge planning, including assessment of health literacy, medication safety, environmental risk, and post-discharge support needs. Patients who are unhoused are offered weather-appropriate clothing, a meal, and transportation to their preferred location or local support agencies, reinforcing our belief that meeting basic needs is part of patient safety. Interpreter services and bilingual staff help ensure services are culturally responsive and understandable.

Monthly multidisciplinary review of SDOH referrals, ECM engagement, and outcomes helps us monitor performance and identify disparities in follow-up, access to resources, and transitions of care. This allows ongoing improvement in how we address social risk to support equitable, personcentered, and safe outcomes.

Performance in the priority area continued

Performance across all of the following priority areas.

Effective treatment

Adventist Health Ukiah Valley (AHUV) promotes effective treatment by delivering care that is evidence-based, timely, coordinated, and aligned with patient goals. Clinical care follows national standards including Centers for Medicare & Medicaid Services (CMS) Core Measures, California Maternal Quality Care Collaborative (CMQCC), American Heart Association (AHA) stroke guidelines, Sepsis (SEP-1), and Choosing Wisely recommendations. Multidisciplinary rounding ensures treatment plans are reviewed by physicians, nurses, pharmacy, case management, social work, ECM, and palliative care when appropriate. This supports real-time care adjustments and safer transitions.Đ

High- and moderate-risk patients are identified using readmission risk scores, and follow-up appointments are scheduled within 7â??10 days of discharge whenever possible. If a patient has no Primary Care Provider (PCP), a hospital follow-up is scheduled before discharge to prevent delays in ongoing treatment. Patients who qualify for Enhanced Care Management (ECM) receive warm handoffs to outpatient care teams for better continuity, symptom management, and chronic care support.Đ

Effective treatment also includes early use of specialty consults. Palliative care is engaged when patients present with advanced illness, high symptom burden, or multiple readmissions, supporting goal-aligned care and reducing avoidable hospitalizations. Patients with substance use disorders are connected to the Substance Use Navigator, addiction medicine, and behavioral health services before discharge.Đ

Medication safety is reinforced through reconciliation, affordability screening, and teach-back education that is culturally appropriate and language-accessible. Discharge plans incorporate Social Drivers of health (SDOH) needs and support referrals for housing, transportation, food access, and behavioral health when needed.Đ

Treatment effectiveness is monitored through monthly review of readmissions, SEP-1 compliance,

stroke timelines, sepsis care, and ECM referral outcomes. Metrics are stratified by age, race, sex, and payer to identify variation and drive equity-focused improvement.

By combining evidence-based care, risk stratification, specialty engagement, and coordinated followup, we support safe, effective, and person-centered treatment for all patients.

Care coordination

At Adventist Health Ukiah Valley (AHUV), care coordination is a central component of safe and effective care delivery. Providers, nursing, case management (CM), social services, and ECM teams work together to ensure seamless transitions from hospital to home, outpatient care, or community services. Care coordination is at the forefront of the treatment team, with providers coordinating with external clinics, specialists, and post-acute facilities, while CM collaborates with home health, Skilled Nursing Facility (SNF), Federally Qualified Health Clinic (FQHC), tribal health, and other service providers.Đ

Discharge planning is collaborative and starts early. Follow-up appointments are scheduled before discharge, including hospital follow-ups for patients without a Primary Care Provider (PCP). When eligible, patients are referred to Enhanced Care Management, and warm handoffs are completed to support continuity of care. Medication reconciliation, transportation planning, and clear discharge instructions ensure patients feel supported after leaving the hospital.Đ

When patients screen positive for SDOH concerns, coordination between CM and community partners becomes essential. Patients are connected to housing programs, food resources, transportation support, addiction services, behavioral health, and recovery programs. This coordination ensures that patient needs outside the hospital are addressed to support safe recovery and prevent avoidable readmissions.Đ

Weekly interdisciplinary rounds allow care teams to review complex needs, discharge readiness, and coordination barriers, supporting real-time problem-solving. Care coordination performance is reviewed monthly through tracking ECM referrals, follow-up completion, readmission trends, and SDOH-related outcomes.

By aligning medical care, social services, and community supports, AHUV ensures that patients experience smooth, safe, and patient-centered transitions across the continuum of care.

Access to care

Adventist Health Ukiah Valley (AHUV) supports access to care by ensuring that all patients, regardless of risk level or provider status, are connected to appropriate follow-up services after discharge. We work with a vendor to coordinate appointments for high- and moderate-risk patients, scheduling follow-up visits within recommended timeframes with either primary care or specialists based on attending provider guidance. Low-risk patients also receive appropriate follow-up care or appointments as determined by their provider.Đ

For patients without an established Primary Care Provider (PCP), we connect them with local Federally Qualified Health Clinic (FQHCs), rural health clinics, tribal health partners, or telehealth-based providers. These partners hold appointment slots specifically reserved for hospital discharge follow-up, improving timely access and reducing delays. Case management, Enhanced Care Management (ECM), and social work teams help coordinate scheduling, confirm appointments before discharge, and provide support for accessing transportation, insurance resources, or community supports.Đ

To address access barriers related to Social Driver of Health (SDOH), patients are screened at admission and referred to housing, food, behavioral health, addiction medicine, or transportation resources when needed. Interpreter services and bilingual staff ensure access to care is equitable for patients with language and literacy needs.Đ

Access to care performance is monitored monthly, tracking follow-up appointment completion, readmissions, no-show rates, and SDOH-related referrals. These metrics inform improvements in coordination, provider partnerships, and resource connections. Đ

By combining discharge planning, vendor-supported scheduling, community partnerships, and SDOH support, Adventist Health Ukiah Valley promotes timely, equitable, and coordinated access to care for all patients.
